Harmonization of local Intraday auction products in Belgium and The Netherlands and Time shift of French 30 min Intraday auction

Summary

In Clearing Circular 36/2020 "Launch of local Intraday auction products in Austria, Belgium, France and The Netherlands" ECC had announced the **harmonization of the Belgian and Dutch product groups** that are currently being used for both Intraday continuous trading **and** Intraday auction trading on EPEX SPOT.

From 1 July 2021 both will be split up into 2 distinct product groups:

- EPEX_IT1_POWER_TNT will be newly set up for Intraday auction trading.
- EPEX_IT1_POWER_ELIA will be **newly** set up for Intraday **auction** trading.

Product Setup and Physical Settlement

In general:

- EPEX_IT_POWER_TSONAME will be used for Intraday continuous trading only.
- EPEX_ITX_POWER_TSONAME will be used for Intraday auction trading only.

Nominations Process

Currently the volumes of the local **French 30 min Intraday auction** are nominated at 16:06 CET on Intraday hub RTE (France), D for D+1. Due to the shift of the auction to 17:00 CET the volumes of the auction will be nominated first at 17:36 CET.

Reporting

The transactions of the new auctions will be captured in reports currently available. The reports will remain unchanged (structure, layout, type of information, etc). The new product groups will be included in the report.

Financial Settlement

Financial settlement process will remain unchanged and the new product groups will be included in your invoices and reports.

Trading Limits

No specific action is required.

Direct Clearing Participants will not be able to participate in the local **French 30 min Intraday auction** due to the shift of auction.
